Tournament Rules and Regulations

ENTRY DEADLINE: October 09, 2010

- 1 This is a **USBC sanctioned tournament**, and will be held under USBC Rules and Regulations
- 2 **Eligibility:**
 - A. All entrants must hold a valid current USBC card.
 - B. Max mixed 4 person team average 860.
- 3 **Mixed 4 Person Team**
 - A. Entries will be taken on a first come, first served basis. **Entries will close on October 09, 2010 ... 1/2 hour prior to each squad ... this will be strictly enforced.**
 - B. Teams must compete with 4 bowlers: 2 men 2 women ... 3 men 1 woman ... 3 women 1 man
 - C. You may bowl multiple squads, however the following Rule applies:
 1. At least 2 players in the lineup must be different in order to place on the prize list. (Rule #315b)
- 4 **Averages and Handicap**
 - A. Tournament committee may reject any entry or Rerate any bowler's average. (Rule #303) If the Rerated average assigned by the tournament committee is not accepted by the bowler, the entry fee shall be refunded (Rule #319c). Previously Re-rated bowler must report Rerated average prior to competition or face disqualification and is not subject to a refund of entries.
 - B. All bowlers must use their highest 2009/2010 book average.
If none, use highest 2008/2009 book average.
If none, use 2010 summer league average of 21 games or more. Must have league sheet for verification.
If none, use current 2010/2011 league average of 21 games or more. Must have league sheet for verification.
Average will be verified before squads begin.
 - C. Handicap will be computed on 90% of 230 average.
- 5 **Payoff**
 - A. USBC cards will be verified before payoff.
 - B. Payoffs will be about 1 to 5 ratio. (Rule #308c)
 - C. 100% return of prize fund. (Rule #308a)
- 6 **USBC Rules in effect**

319a-3, 319a-5, 319d, and 328 will apply to all entrants

Teams violating any of the above mentioned USBC rules will be subject to disqualification and will forfeit all entry fees and prize monies.
- 7 Premature termination of the tournament brought about by national emergencies, or emergencies caused by or related to fire, natural disasters, or any other reason beyond the control of Rodeo Lanes shall cause all advertised prizes, quaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled in each of the respective squads up to the time of such termination.
- 8 **Any questions or disputes not governed by the above rules shall be decided by the tournament committee. (Rules #303c)**
